Scope and Contents and Arrangement

Ledgers are largely arranged by court or record type and listed chronologically within each series. Ledgers in the unclassified series may be from other existing series but were not identified as such during processing.

Series I: Real and Personal Property records, 1819-1990

Includes records of assessments, taxes paid, delinquent taxes, land ownership, confiscation and lawsuits, mortgages, deeds, and liens, and chattel mortgages.

Series II: Marriage records, 1821-1994

Includes marriage certificates and indexes to marriages.

Series III: Circuit Court records, 1838-1958

Includes dockets, and records of indictments and fees.

Series IV: Chancery Court records, 1839-1982

Includes dockets, fee books, records of disposed cases, child support and alimony.

Series V: Civil Court records, 1881-1983

Includes dockets and fee books.

Series VI: Criminal Court records, 1857-1973

Includes dockets and fee books.

Series VII: Common Pleas Court records, 1819-1900

Includes dockets and fee books.

Series VIII: Grand Jury records, 1903-1961

Includes dockets and records of jurors and indictments.

Series IX: Justice of the Peace records, 1915-1951

Includes dockets.

Series X: Ross Drainage District records, 1943-1949

Includes record of assessments and receivership taxes.

Series XI: Unclassified record books, 1845-1993

Includes dockets, wills, fee books, indexes, records of contracts, road and dog taxes, naturalization and petition records, warrants, bonds, record of county jail prisoners, paving districts, and poll tax receipts.

Historical Summary

Clark County, Arkansas, established on December 15, 1818, is one of the state's oldest counties and was named for William Clark of the Lewis and Clark Expedition. Originally part of the Missouri Territory, the county developed quickly due to its fertile farmland, timber resources, and the Ouachita River, which made Arkadelphia a hub for trade and transportation. During the Civil War, Arkadelphia served as a Confederate supply center. After the war, the arrival of railroads fueled the timber and manufacturing industries. Education became a hallmark of the county with the founding of Ouachita Baptist University in 1886 and Henderson State University in 1890.

Clark County's government operates under the quorum court system, the legislative body for the county. The quorum court is composed of justices of the peace, elected from local districts, who pass ordinances and manage county finances. The county judge, elected by voters, serves as the county's chief executive officer. The judge oversees daily operations, maintains county roads, manages services like solid waste and emergency preparedness, and executes the quorum court's decisions. Other elected officials include the sheriff, clerk, assessor, treasurer, and coroner, each responsible for specific functions. This structure ensures a balance of legislative and executive powers while providing responsive local governance.
