Historical Summary

The Davidson Methodist Campground is located in Clark County, Arkansas, approximately three miles southwest of Hollywood. The campground was named for the donor of the land, Jerry Davidson. Revivals have been conducted there every summer, with the exception of 1905, for over one hundred years.
