**Hickingbotham School of Business**

<b>Department</b>	<b>Proposed Changes</b>	<b>Rationale</b>
Accounting	<p>Delete ACCT 4103 CPA Problems. Add ACCT 4xx3 Current Accounting Issues and Topics.</p> <p>Proposed Effective Date: January 1, 2008</p>	<p>Recently there has been some confusion caused by the CPA Problems (ACCT 4103) course title when transcripts for students sitting for the CPA Exam in Texas were reviewed by the Texas State Board of Accountancy. The requirements in Texas prevent a student from using hours earned from an external professional CPA review course as part of the 36 hours of accounting needed to sit for the CPA Exam. The title of this course has caused some confusion that this course is like one of those. We have had to submit course descriptions and other documentation about the content and structure of this course. In each case, when this was done the course was approved as meeting the requirements to sit for the CPA Exam. By dropping the old course and adding the new one we hope to eliminate the problems and delays the title of the old course caused for our students. We believe it will be easier to add and drop the courses than trying to change the name of the old course because the same course number will show up on some transcripts as the old course title and under the new course title on future transcripts.</p>

**Pruet School of Christian Studies**

<b>Department</b>	<b>Proposed Changes</b>	<b>Rationale</b>
Christian Ministries	In the basic requirements for Christian Studies, indicate the option to take CHMN 3123 Communicating the Gospel or CHMN 4213 Homiletics.	Many of our students plan to go into preaching ministry and would choose to take Homiletics if they had room in the schedule for it. Communicating the Gospel and Homiletics will cover much of the same material with different emphases in mind. We feel either of the courses would accomplish the same purpose for the student and therefore we prefer to give them the option between the two.
Christian Ministries	Increase the frequency of CHMN 3103 Christian Counseling from Spring of even-numbered years to every Spring.	Many of our Christian Studies students plan to go into Christian Counseling and other Christian Studies students feel this course would benefit them in their ministry. Offering the course more often would allow more students to opt for it. All Christian Ministries majors would benefit from some basic counseling information.
Christian Missions	<p>Add a new course, MSSN 4xx3 Islam.</p> <p>Course Description: An examination of the beliefs, practices, and diverse communities of Islamic traditions. Topics include contemporary issues and Christian response. Prerequisite: Junior Standing. Fall of Even Years</p>	Islam continues to be one of the fastest growing and most aggressive world religions. Students planning to go into missions or ministry will no doubt encounter the Islamic faith in their work. Even students who plan to engage in international business will likely face issues growing out of Islamic culture. We believe many of our students would benefit from a deeper investigation of Islamic faith and culture. World Religions offers an introduction but a dedicated course is needed for those who plan to live and work in countries where Islam is predominant.

Spring of even-numbered years.</p>	<p>A course in these topics is often requested by our majors and is needed to fill a gap in the philosophy curriculum of courses that cover the current state of philosophy in central areas of study. This also allows us to more effectively capitalize on the strengths of our newest faculty member.</p>
<p>Philosophy</p>	<p>Move PHIL 2163 Death and Dying from Fall odd-numbered years to Spring odd-numbered years.</p>	<p>This change of offering provides better coordination of Philosophy course staffing with staffing by Philosophy faculty to serve CORE needs.</p>
<p>Theology</p>	<p>Revert to the former course configuration whereby THEO 4233 New Testament Theology was offered as one course. Theology majors would take THEO 4233 New Testament Theology instead of the two current separate courses THEO 4243 Jesus and the Kingdom of God and THEO 4253 Theology of Paul. The "extra" slot created by combining THEO 4243 and THEO 4253 will be devoted to offering the THEO 4801-4893 Special Studies in Christian Theology every fall rather than, as it is now, only on demand.</p> <p>Catalog Descriptions: THEO 4233 New Testament Theology - A study of the theological themes of the New Testament (Spring)</p> <p>THEO 4801-4893 Special Studies in Christian Theology – Prerequisite: Permission of the Department Chair and Dean (Fall)</p>	<p>THEO 4133 Old Testament Theology is currently taught as only one course, covering more material than the New Testament; so should the THEO 4233 New Testament Theology course be taught as one course. THEO 4243 and THEO 4253 have proved to be redundant, rehashing the Biblical Studies courses Life of Christ and Life and Letters of Paul, respectively. Offering THEO 4801-4893 Special Studies in Christian Theology will provide a cutting-edge look at significant, fast developing trends in current theological studies.</p>

**Huckabee School of Education**

<p>Education (All Majors)</p>	<p>Restructure the requirements for the major in education by (1) combining some student teaching “block” courses with other required courses and (2) removing some specified prerequisites:</p> <p>Delete EDFN 4052 Instructional Skills. The content of this course would be covered in other courses throughout the various licensure programs.</p> <p>Delete EDFN 4092 Classroom Management. The content of this course would be covered in the appropriate development level methods/practicum courses, including SCED 4073 Secondary Methods, MSED 3043 Middle School Methods, and ECED 4043 Practicum in Early Childhood Education. To reflect this change, we also propose changing the names of these courses as follows: SCED 4073 Secondary Methods and Classroom Management; MSED 3043 Middle School Methods and Classroom Management; and ECED 4043 Practicum in Early Childhood Education and Classroom Management.</p> <p>Combine EDFN 3023 Learning Theories and EDFN 4022 Measurement and Evaluation to create a new course, EDFN 4123 Learning Theories and Assessment Practices.</p>	<p>These changes will ensure that candidates have information needed earlier in their programs while both streamlining and enhancing the education programs. For the middle school licensure area, it will allow us to meet the state required changes.</p>

	<p>Remove prerequisites for EDFN 2012 Instructional Technology and EDFN 2053 Child and Adolescent Development.</p> <p>Effects of Changes: Overall, the “block” during the student teaching semester will be deleted, giving students/candidates an earlier start in schools during the student teaching/internship semester. Secondary Education programs will have a reduction of credit hours needed for graduation and certification in secondary programs. The change in hours for the Middle School Education program will help offset new requirements for a generalist middle school licensure program. The reduction will also help offset a change for Early Childhood Education majors, because the math sequence (including math pedagogy) will increase by three hours, and EDFN 4123 replaces EDFN 4022.</p>	
<p>Education (All Majors)</p>	<p>Add a minor in Education and Public Policy focused on preparing students to serve in local, state, or national policy-making positions.</p> <p>Students will be required to complete 6 credit hours in education courses, 6 credit hours in political science courses, 6 hours in a concentration area, and 3 hours in a field experience course (EDFN 4xx3 Education and Public Policy Field Experience) for a total of 21 credit hours. See Education proposal for details.</p>	<p>Policy-making positions exist in every local community, as well as at the state and national levels. Individuals who fill these positions, whether elected or appointed, make decisions that impact the quality of life for the citizens of that community, the state, or the nation. It is important for policy-makers to understand the far-reaching effects of the policies they create. Policy-makers need to know how to analyze the broad impact of their policies and how to access the best information available to make those decisions. As OBU prepares students for service in a variety of</p>

		<p>areas, these students can also be prepared for public service in full time public policy positions or through volunteer opportunities. By creating a minor in education and public policy, students majoring in a variety of academic areas can learn how to use their talents and creative abilities to serve in the public policy arena. <p>Education (All Majors)</p>	<p>Add a new course, EDFN 4xx3 Education and Public Policy Field Experience.</p> <p>Course Description: Students in this course will participate in a field experience set in a public-policy making venue. Prerequisite: Junior standing or consent of instructor. On Demand</p> <p>Additional Course Information: Students will be assigned to work with policy makers, such as legislators, city leaders, congressional representatives, or other elected or appointed public officials. The students will participate for 3 hours per week in one of these settings, keep a journal of their observations, and complete a final project. Students will also meet in one hour seminar sessions twice a month to discuss, analyze, and evaluate experiences in policy-making settings.</p>	<p>This course is one of the requirements of the proposed minor in Education and Public Policy.</p>

	<p>During odd numbered spring semesters, preference will be given to assigning students to work with state legislators during the legislative session. It does fulfill Association of Christian Schools International (ACSI) philosophy and course requirements. Education majors may take EDFN 2014 Education in the Christian School: Philosophy and Practice course as an elective. To achieve a minor in this area, the students will need to have a major in a field other than education. All prerequisites apply for all courses listed in the minor. At least 24 hours are required as indicated below.”</p> <p>Remove EDFN 4052 Instructional Skills from the requirements for this minor.</p>	<p>Any student who completes an education major could also teach in any of the settings as currently described for this minor. Some education majors may want this experience from this course and not realize they could elect to take it.</p> <p>The prerequisites for some of these courses have not been enforced intentionally in the past. First of all, we do not think it sends an appropriate message about the qualifications needed for teaching in Christian Schools or other settings that may or may not require certification. Further, this is causing in some cases and could cause us future concerns as we approach re-accreditation.</p> <p>Therefore, if students choose this minor they must meet the prerequisites for all of the courses. This means that for upper division Education courses candidates will have to take Praxis I and have “C” or better in Comp I and II and Liberal Arts Math and any professional courses attempted, and a 2.5 GPA and admission to teacher</p>

Recreation and camp programs, particularly Christian camps, are eager to find someone that has a combination of these skills. The classes in the School of Christian Studies will have a very small increase in enrollment due to the minor. Dr. Terry Carter, Chair of the Department of Christian Ministries and Dr. Danny Hayes, Dean of the Pruet School of Christian Studies, have both approved the inclusion of their courses in the minor.</p>

Music	Require one semester of MUEN 1020.5 Piano Ensemble for the BM in Piano Performance degree.	This change will provide collaborative and ensemble experience for majors with a piano emphasis. Not only as professional musicians will they perform two-piano and piano duet repertoire themselves, but they will also teach this literature in private studio lessons and in group teaching situations. It is essential that they learn the repertoire that is available and develop a full understanding of the performance practices and pedagogical requirements in dealing with this genre of music.
Theatre Arts	Change THEA 4223 Shakespeare from Spring of even-numbered years to Fall of even-numbered years.	This course is taught by the English Department but double listed because it is required for our Theatre majors. The English Department has moved the semester in which they offer the course, and our change will keep the double listings consistent.
Theatre Arts	Add two hours of THEA 1011 Theatre Practicum to the Theatre Arts Minor.	As an applied art, students should not be able to receive a minor in theatre without having to participate in producing theatre. Our minors have already been doing this, and more, but the requirement needs to be spelled out up front by being in the catalog. This moves the minor from 18 hours to 20 hours but does not affect faculty course loads as the course is offered every term.

Theatre Arts	<p>Change THDA 3002 Musical Theatre Choreography to include the prerequisite of four previous hours of THDA courses or consent of instructor.</p> <p>Catalog Description:  <i>A practical course that studies and applies the art of directing and choreographing musical numbers for a stage musical. Prerequisite: four completed hours of THDA courses, or consent of instructor.</i></p>	<p>The course is an upper level dance course that will require diverse dance background of the students. Students outside of the department are attracted to the course for its two hour junior level and can currently enroll in it without having had any dance experience.</p>
Theatre Arts	<p>Change THEA 4303 Studies in Drama from Spring of odd-numbered years to on demand.</p>	<p>This course is taught by the English department but double listed because it has been an option to fulfill a requirement for our Theatre majors. The English department has changed when they offer the course to “on demand.”</p>
Theatre Arts	<p>Change THEA 4033 Dramatic Theory and Play Development from on demand to Spring of even-numbered years.</p>	<p>This course has been taught on demand, but was changed to a required course for theatre majors, starting with the 2007-2008 catalogue. As a required course, it needs to be offered on a regular basis.</p>

English	Add ENGL 3003 Advanced Composition as a requirement for the minor in English/Writing.	We want to require this course in rhetorical principles and forms of expository writing.
English	Add to the English/Writing minor the option of taking two of the following four Mass Communications courses: COMM 2073 Motion Picture Script Development; COMM 3013 Feature Writing; COMM 3103 Opinion Writing; COMM 4043 Advanced Reporting for the Mass Media	These courses fit well with the objectives of the English/Writing minor.
English	Delete ENGL 4173 Folkways of the Arkansas Red River Region I and ENGL 4183 Folkways of the Arkansas Red River Region II.	These courses used to be offered in the summer. They have not been offered for many years. These courses were created by Professors Lavell Cole and Tom Greer, both of whom are deceased. There does not exist current staffing interested in teaching these courses. When OBU had a graduate program, the courses proved attractive for teachers needing credit hours in the summer. That too is obviously no longer applicable.
Speech Communication	Drop SPCM 2003 Oral Interpretation.	The course is currently listed as “on demand.” It has only been taught twice in the past 14 years. There is no student or teacher interest in the course.

The course has been offered as a special study in the fall and spring for the past few years and has had full enrollments (20-24 students) each offering.</p>
<p>Modern Foreign Languages</p>	<p>Add SPAN 3153 Linguistics as a requirement for Spanish education majors.</p> <p>Catalog Description: This course will present a study of Spanish and English phonetic and phonological features. Students will analyze prominent characteristics of the pronunciation of Hispanic dialects – Peninsular Spanish, the Spanish of the Americas, and the three major Spanish-speaking groups in the United States (Chicano, Cuban, and Puerto Rican). Prerequisite: At least one three-hour course at the 3000 level or consent of instructor.
