With the modification of the course KIN 1003 Foundations of Kinesiology to Foundations of Kinesiology and Leisure Studies, much of the introductory materials for the recreation emphasis are now included in KIN 1003.</p> <p>The Outdoor Leisure Pursuits course has evolved to a more specialized course dealing with topics specific to a person entering the field of recreation. The faculty of the Department of Visual Arts has completed a curriculum review. During this process we identified Mixed Media, Illustration and Rendering, and Three Dimensional Modeling as outdated and being very similar in media and content to</p>

		Drawing III. A “mixed media” approach is used in sculpture and experimentation with media is a natural progression in Drawing and Painting. These classes were created around specific skills of faculty members that are no longer present at the university.

We currently rely on the painting courses to provide this information, which is in fact a basic skill they should enter the class knowing then build on those skills using paint as the media. We have found our students need more instruction on color theory and implementation to be adequately prepared for graduate studies or the professional world.
